TOURNAMENT RULES

- 1. Entrant must be a member of the Cecil Harford USBC Association.
- 2. Entrants will compete in a handicap tournament with divisions based on bowler's average.
- 3. Handicap will be 90% of 220.
- 4. Entering average:
 - A. Highest USBC certified average for the previous season (winter & summer) 2024-2025 for twenty-one (21) games or more from any association shall be used.
 - B. If no average from last year, highest current season (2025-2026) USBC certified average from any association for twenty-one (21) games or more as of the closing date of the tournament. A league standing sheet must be provided for proof of current average.
 - C. An entrant with no book average must bowl scratch.
- 5. Each bowler will be responsible for the accuracy of their average whether submitted by them or another person. USBC Rule 319a (2) (10 pin up) rule will be waived.
- 6. Entrants will bowl three (3) games, moving after the completion of each game.
- 7. A stepladder final will be held for both divisions to determine the handicap champion. If there are more than 15 participants in a division, the top 5 qualifiers will advance to the stepladder finals. Less than 15 participants, the top 3 qualifiers will advance.
- 8. Each qualifying entrant will be given 2 practice balls on each lane. In case of a tie in the stepladder for any position, there will be a 9th and 10th frame roll off.
- 9. The prize fund shall be 100% handicap prize paid to at least 1 in 5 entries in each division. All prize fees collected in a division will be returned 100% to the participants in that division.
- 10. Any protest must comply with USBC rule 329.
- 11. Errors in scoring must be corrected within 48 hours. Participants must immediately notify the tournament manager of any scoring errors.
